Welcome to the July update from the ECB Safeguarding Team

We have produced this update to keep you informed on a range of topics and provide further best practice guidance to the game. By way of an update, we are currently progressing several projects away from our normal business. This in some part may affect you in your roles across the game in the future.

We are currently working to:

- · Pilot a Talent Pathway Safeguarding Course
- Update Safe Hands Guidance and release to the game
- Support with The Hundred delivery including Event Safeguarding Officers
- Pilot our low level concerns interim solution and deliver to the rest of the cricket network.



We would like to thank you on behalf of the team for your continued support at this busy time in the season. We continue to be on hand to support you as and when required.

Low Level Concerns

The ECB Safeguarding Team and Anti-Discrimination Unit are working closely together to provide an interim solution for the recording of low level concerns. Legal advice has been sought and we are now able to move to a pilot phase. This pilot will involve nine counties in the Midlands area, who will be asked to upload their low level concerns data from 2022/2023. Over the course of the pilot, we will test the following:

- Is the technological solution fit for purpose, allowing us to see a game wide view of low level concerns from initial referral all the way through to closure of the case?
- Has communication and training, including how the ECB deliver and provide ongoing support to counties throughout the length of the pilot, been appropriate?
- Is the triage process, including the recording of decisions and escalation where appropriate, fit for purpose?
- Does the creation of reports highlighting risk allow counties/ECB to identify where proactive safeguarding is required?

The pilot phase is expected to last around four weeks. Following this, further communication will be sent out to you all with an update regarding the outcome of the pilot and plans to roll out the system to the rest of the network.

Board Safeguarding Leads attending the ECB Safeguarding Conference this year had the opportunity to watch, listen and ask questions about a Schools Community Project involving pupils and staff from Broadway Academy and Radley College.

We found the use of video particularly powerful when speaking with children and especially using this medium for 'Listening to Children' and/or 'Voice of the Child'.

A short time later, John Sparks from Radley College was kind enough to take part in a short webinar to discuss the project with County Safeguarding Officers. Feedback from the webinar was incredibly positive with comments including 'the most worthwhile session I have listened to', 'an inspiring project' and 'we want to do the same in our area'.
